CREDIT REPORTS AND CREDIT SCORES

You should check your credit report at least once a year and can receive free copies every 12 months from <u>annualcreditreport.com</u>. Check your credit report to be sure the information is correct and up to date. Report any errors and fix any Mistakes that you find. Your report provides information on how to dispute a Mistake. Credit scores are based on information from your credit report, so it is important the data is correct. Scores normally range from 300 to 850 and the higher the score the better. To raise your score, pay your bills on time, do not get close to your credit limits, maintain long history with the same provider, be careful when closing accounts and only apply for credit that you need. Loan payment must be current. Emergency Loans, Note Loans, and Lines of Credit are not eligible. You may skip only one monthly payment (or its equivalent). Complete the above form and submit at least 3 business days before the payment you want skipped is due. If you use a coupon book, move the coupon for the month you are skipping to the back of the book. The term of any Credit Life and/or Disability Insurance coverage purchased in connection with the original obligation will NOT be extended for the additional term provided in the Skip-A-Payment agreement. However, Galaxy Payment Protection will continue as long as the loan is in repayment status. When you take advantage of this offer, we will shift your deferred payment to the end of your payment schedule, extending your maturity date by one month. Interest will continue to accrue on the unpaid balance of your loan during the deferment period. Some members and/or loans are not eligible. See any employee for questions.

GAP Plus

We have added another benefit to our GAP Product and lowered the cost! GAP Plus may reduce or eliminate the gap between what your vehicle insurance will pay and what you owe, if your vehicle is deemed a total loss. Plus if you get your next vehicle at Galaxy, it reduces your loan by \$1,000. And now, we offer Deductible Assistance to provide financial relief when your vehicle is damaged, but not deemed a total loss. If auto repairs cost more than your deductible, the deductible amount is applied to your loan! Cost is only \$400 and can be added to any vehicle that is financed at Galaxy.
