Late last year I shared with the credit union volunteers and employees that I planned to retire in early 2023. While that didn't happen, I am now announcing that I will retire in July 2023.



During my 32 years here, the credit union has gone through many changes. We changed the name from Joy Federal Credit Union to Galaxy Federal Credit Union, using the 12 stars in our logo to signify the 12 original founders, all Joy Manufacturing employees; we moved to our current location in 1995; and converted to a community credit union to serve all of Venango County in 2002. We grew from \$8 million in assets to \$60 million; grew our loans from \$5.6 million to over \$30 million; and increased our membership from 3,500 to almost 5,000. This was possible due to the strong leadership of our credit union volunteers and teamwork by all of our employees.

The Board of Directors and I conducted an extensive search to find my successor. We worked hard to find someone that would share our passion to lead the credit union through whatever the future may bring. I am happy to introduce Donald 'Chip' Pfohl as the next President/CEO of Galaxy Federal Credit Union. Chip is a graduate from Penn State University. He moved to Franklin from Pittsburgh with his wife, Janene, in 1993. They love the area and raised their two children here, now both adults. He has worked in the financial services sector for 30 years. Chip joined Galaxy in March 2023 and we are confident that he will be a great leader for the credit union.



I want to personally thank the credit union volunteers, employees, and members for allowing me to be your President / CEO for the past 32 years. As for me, I plan to spend more time with my family and friends, to travel, continue to volunteer, and pursue hobbies and activities that interest me.

Loan payment must be current. Emergency Loans, Note Loans, and Lines of Credit are not eligible. You may skip only one monthly payment (or its equivalent). Complete the above form and submit at least 3 business days before the payment you want skipped is due. If you use a coupon book, move the coupon for the month you are skipping to the back of the book. The term of any Credit Life and/or Disability Insurance coverage purchased in connection with the original obligation will NOT be extended for the additional term provided in the Skip-A-Payment agreement. Payment Protection Plan coverage will continue. When you take advantage of this offer, we will shift your deferred payment to the end of your payment schedule, extending your maturity date by one month. Interest will continue to accrue on the unpaid balance of your loan during the deferment period. Some members and/or loans are not eligible. See any employee for questions.
